



I am at least 18 years old, or I am the parent or legal guardian of a person under the age of 18, and wish to enter into this Agreement, either on my behalf or on behalf of my minor child, with Gymnastics World, Inc. and its subsidiaries and affiliates (“Gym World”) for athletic instruction and related services. I understand that this Agreement will not be effective until it is signed and all of its terms have been complied with. No person covered by this Agreement may use any Gym World facility without agreeing to Gym World’s Terms and Conditions and any applicable Team Agreement. Any aspect of this Agreement may be amended and the rights in and to this Agreement may be assigned by Gym World without notice.

I agree to pay the Fees and Tuition in the Fee Form including enrollment and/or administrative fees as designated from time to time by Gym World. These are non-refundable fees, except as otherwise described below. Gym World reserves the right to determine the amount and terms of payment of Tuition and any other fees, including service, late or invalid payment fees, all of which dues and fees may be increased in Gym World’s sole discretion. My obligation to pay Tuition is not dependent upon usage of Gym World’s facility, participation in Gym World’s programs, or availability of or access to all of Gym World’s facilities.

This Agreement shall be for a period of one year and shall automatically renew each year unless I provide written notice to Gym World that I do not wish for the Agreement to renew.

If by reason of death or disability, I am unable to receive benefits from Gym World’s services, the Agreement shall be proportionally divided by all of the days in which the facility was made available to me as part of the contract offering, and I shall be liable for payments only for that portion of the Agreement that can be attributed to the period prior to my actual death or disability.

If I relocate twenty five miles or more from the facilities operated by Gym World or a substantially similar facility that would accept Gym World’s obligation under the contract and if I give Gym World written notice that I intend to relocate and request that the contract be terminated, the contract shall be proportionally divided by all of the days in which the facilities were made available to me, and I shall be liable for payments only for that portion of the contract that can be attributed to the period prior to my actual relocation, provided, that Gym World may require and verify reasonable evidence of relocation. If Gym World relocates its facility twenty five miles or more from my residence or closes its facilities and a substantially similar facility that would accept Gym World’s obligation under the contract is not within twenty five miles of my residence, the contract shall be proportionally divided by all of the days in which the facilities were made available to me as part of the contract offering, and I shall be liable for payments for only that portion of the contract that can be attributed to the period prior to Gym World’s actual relocation or closing of the facilities.

I acknowledge that I have been informed of my right to cancel.
